# BUDGET AND FINANCIAL DATA

The fringe benefits rate for stipends and summer salary at Bethel University is currently **14%**. This rate includes FICA and retirement contributions. The benefits rate for other salary is **31.04%**. This rate includes FICA, retirement, health insurance dental; insurance, life insurance, and long-term disability. We anticipate a 2% increase per year for each of these fringe benefits rate.

**Summer Salary (Faculty)**: Summer salary per month cannot exceed the base monthly salary for the academic year.

Release Time for Faculty: Must use actual salary.

Stipends: Varies.

**Student Salary Rates**: \$9.50 to \$13.00/hour but may vary. Check with Human Resources: https://www.bethel.edu/human-resources/student-employment/supervisors/after-hiring.

**Undergraduate Student Research Rates**: \$10.00 to \$13.00/hour but may vary.

**Indirect Cost Rate**: Our negotiated rate with the Federal Government for Facilities and Administrative Costs (F and A) is 54%. This applies solely to direct salaries and wages including all fringe benefits. **Fringe Benefit Rates**: These rates may change every year; be sure to use up-to-date number. Rates below are for the 2017–2018 academic year.
